Without Aid

Sir/Madam, In view of your proposal on the subject cited above I am directed to convey the approval of

the Director of Education for the recognition of the school upto Secondary level w.e.f. academic session 1996-97 (without aid) subject to the following terms and conditions:-

- 1) The school is being recognised upto Secondary level as an integrated school comprising general & physically handicapped children w.e.f. 1996-97 academic session without aid.
- 2) The school will immediately surrender its primary recognition letter for primary classes to the MCD authorities and submit a compliance report.
- 3) The grant received from Govt. of India (Ministry of HRD & Ministry of Welfare) for the Special wing (IEDEGVU) will not be treated as grant-in-aid under the Delhi School Education Act & rules, DSE.
- 4) As far as the utility of the land (Masjid Nithi site) is concerned, the Management of the school may sort out the matter with Delhi Development Authority and report accordingly to this office.
- 5) The school shall admit students without any discrimination of caste and creed.
- 6) That the school shall strictly not run any unauthorised classes or any other activities within the school premises and all the recognised classes shall be run at one place at the premises of the school immediately, if any.
- 7) That the school shall strictly abide by the provisions of section -10(1) of DSE, 1973.

- b) That all the facilities prescribed under rule 50(8) of DSER, 1973 shall be made available to the students.
- c) That the school shall dispose with the services of unqualified and overage staff, if any, immediately and appoint qualified staff.
- 10) That the service contract between the Management and the employee be revised as per DSER, 1973 and shall be executed immediately.
- 11) The Managing Committee of the school shall regulate the functioning of the school strictly in accordance with the provision of DSER, 1973.
- 12) That the violation of any instructions/condition/rules & regulations of the Dpmtt. shall lead to the withdrawal of recognition of the school.
- 13) Managing Committee of the school shall not increase fees in future academic session without the prior approval of the Director of Education which is mandatory requirement under sub-section (3) of Section-17 of DSER, 1973.
- 14) The staff and employees of the school shall be paid salary and allowances as per the recommendations of the Fifth Pay Commission or par with Govt. school teachers.
- 15) Musical facilities, leave, LTC, bonus, teaching allowance, GPF be paid since the recognition of the school.
- 16) Provident Fund register to be maintained and cash register to be completed and shown to the Education officer of the zone concerned for verification from time to time.
- 17) That the Management of the school shall create a reserve fund to the tune of three months salary to the staff of the school.
- 18) That the school shall restrict the enrolment in every class at the ratio of 10 sq.ft. per student.
- 19) That the arrangement for good drinking water shall be made available to the students and the teachers and sanitary facilities shall be provided to the students and teachers.
- 20) That the Science Lab have to be made available in the school and improved/renovated from time to time.
- 21) That adequate sports material shall be purchased and made available to the students.

- 22) That a proper library be made available with all facilities along with a reading room both for the students & teachers.
- 23) Books shall be made available at the ratio of 10 books per student. Proper accession register should be maintained in the school.
- 24) That the report about the fulfillment of the above conditions shall be submitted to the EO of the Zone from time to time.
