





**SUB:- GRANT OF PROVISIONAL RECOGNITION OF THE SCHOOL FROM CLASS Pre-Primary TO Secondary .**

Sir,

With reference to your application on the subject cited above. I am directed to convey the approval of Director of Education, Govt. of NCT of Delhi for grant of PROVISIONAL Recognition of (Balvantray Mehta Vidya Bhawan Anguridevi Shersingh Memorial Academy - SECOND SHIFT) from class Pre-Primary to Secondary w.e.f session 01/4/2014 upto 31/03/2015 subject to the following terms and conditions:-

1. That the school shall abide by the provision of DSEAR, 1973 and RTE, 2009 rules made there under as well as the instructions issued by the Director of Education from time to time.
2. That all the facilities prescribed under section 4 of DSEAR 1973 read with rule 50 & 51 of DSEAR 1973, shall be made available to the students.
3. That the school shall admit the students without any discrimination of religion race, caste or place of birth as per the norms of the Department.
4. That the school shall follow the three language formula for teaching.
5. That the school shall not run any unauthorized classes or any other activities within the school premises and all the recognized classes shall run at one place in the premises of school.
6. That the managing committee shall regulate the functioning of school strictly in accordance with the provisions of DSEAR 1973/RTE Act, 2009.
7. That the Management of the school shall create a reserve fund in the form of Fixed Deposit in the joint account in the name of Manager of the School and Dy. Director of Education (Distt. South East) equivalent to 3 months salary of staff or Rupees One lakh + Rs 80/- per student within 3 months from the date of issue of letter.
8. That in no case the school funds will be diverted/ transferred to any other fund/account of the society. The school funds will also not be utilized by the society for any other purpose other than that of the school.
9. That the school shall ensure that the Fire safety equipments and arrangements are maintained as given in circular No 262-362 dated 17/1/2005 and corrigendum dated 27/1/2005 issued by Directorate of Education.
10. That the school shall comply with the directions of Hon'ble Supreme Court regarding the arrangement made for transporting school students to and fro the school as per Circular No. DE 23(47)/School Br/2004/6942/ 66988 dated 29/9/2004 & 18/11/2005.
11. A certificate from the competent authority that the Building has been constructed as per National Building code 2005 within three months.
12. Salary & other facilities to staff and teachers will be made as per section 10(1) of DSEAR 1973 and relevant section of RTE Act, 2009.
13. Salary to the staff should be made through crossed cheque/ Electronic clearance system.
14. That the school shall provide free and compulsory education to the children as per notification no. 15(172)/ DE/Act/2010/69 dated 7/1/2011.
15. That the annual return Under rule 180 of DSEAR'73 shall be filled with the concerned E.O.
16. That the school abide by the instructions/orders regarding fee-hike, issued by the Dte. of Education.
17. In case of Provisional Recognition to the school situated in Non Confirming Area, the recognition will be subject to the outcome of notification by Ministry of Urban Development Govt. of India, Delhi.
18. That the violation of any instructions/order/rules and regulations of the department, shall lead to the withdrawal of recognition of the school.

19. The School shall submit Building Completion Certificate issued (BCC) from the Local Competent Authority. 20. That the school running in II shift shall run as a 'new entity' and as an independent school, and shall maintain separate records and accounts. 21. The school shall not be considered as any extension of the 1st shift or the morning shift. 22. That the school shall have to get fresh affiliation from the affiliation Board and shall conform to the rules and norms of RTE Act, 2009 and DSEAR, 1973 and rules framed there under. 23. That the school shall have to employ its own staff( both teaching as well as non-teaching including the school Principal as per the applicable Recruitment Rules(RRs) before commencement of II shift. 24. That the school shall not entertain shifting/transfer of students including children belonging to EWS and Disadvantaged Group Category, to 1st Shift or vice-versa under any circumstances. 25. That the school shall admit students strictly following neighborhood criteria in view of safety and security of students studying therein. 26. That the school shall charge development fund and Annual Charges from its students just to made the school financially sustainable. 27. That the school shall not have timings overlapping with the morning shift(1st shift) and there shall be a gap of at least half-an-hour between the two shifts. As per the schedule (Norms and standards for a school) to the RTE Act, 2009 working days/instructional hours in academic year both for the students and the teachers. 28. That the school shall have to share infrastructural facilities of the 1st shift and for this purpose a memorandum of understanding required to be signed by the Managing Committees of both shifts so that the right, responsibilities and limitations of both the shifts are defined. 29. Governing Body/Society/Management of 1st shift school shall not charge any rent or any development charges from the II shift school. This implies that the II shift school shall be under no obligation to pay any rent and /or development charges to the 1st shift. This will ensure that there is no such financial burden/liability on II shift school which may ultimately be passed on to the students studying in II shift. 30. For better coordination, Management of both the schools should be common except for the representative of teachers and students (parents). 31. Adequate security and safety arrangement must be provided for students and staff of Second Shift. Security Guards and Ayahs to be sent as escorts. 32. The School shall submit separate annual information about staff/ students/fee etc as well as the Provident Fund Number of teachers teaching in second shift. The school shall not employ the teachers/staff of the 1st shift in the Second Shift. 33. The school will submit documentary proof for the appointment of special educator in terms of Order dated 19.02.2013 of this Directorate. 34. The school shall submit documentary proof for appointment of Medical Officer/staff as per Rule 38 of DSEAR, 1973. 35. The school shall provide barrier free access to the Children with special needs. 36. The society shall appoint separate Principal and staff, including teaching staff, before commencement of classes and submit the report in this regard within one month of grant of provisional recognition. No staff of morning shift will be allowed to work in second shift as well. 37. The society shall submit the proof of taking the PTA of first shift school into confidence for starting the second shift school within a period of one month of grant of provisional recognition. 38. The school running in second shift shall have to grant admission to students belonging to EWS and Disadvantaged Group category as per the provisions of RTE Act 2009. 39. The trust/societies running the second shift must be financially sound enough to ensure that the trust/society is capable to pay the salary as per govt. Rules to the teachers/ staffs of the schools. It should not happen that after opening the school they express their inability to pay salary as per rules.
