With reference to your application on the above cited subject I am directed to convey the approval of the Director of Education for upgradation of the school from Secondary level to Sr. Secondary level with Humanities and Commerce Stream w.e.f. 2001-2002 without aid subject to the following terms and conditions and in accordance with Rule-52 of DSER 1973.

The upgradation from Secondary to Sr. Secondary level in Humanities and Commerce Stream w.e.f. session 2001-2002 without aid under Rule-52 of DSER, 1973 has been approved with the condition that the discrepancies and deficiencies given below shall be removed by the school within a period of six months from the date of the letter granting recognition. If the Managing Committee of the school emits or fails to remove any of the discrepancies or deficiencies within a period of six months as stipulated and stated above the recognition to the classes-XI & XII granted to the school will automatically lapse without any intimation or notice to the Managing Committee of the school.

Discrepancies and deficiencies

1. As far as the utility of the land (Masjid Meth site) is concerned the Management of the school may sort out the matter with Delhi Development Authority and report according to this office with the relevant documents.
2. Building Plan sanctioned by competent legal authority is required.
3. Fresh structural stability certificate required.
4. Fresh building completion certificate from the competent local authority required.

5. Salary and allowances must be paid to the employees as per the recommendations of the 7th Pay Commission Report.

6. Some of the staff members are ever-aged, some are an asset and some are on consolidated salary. Regular staff must be appointed as per recruitment rules.

Terms & Conditions

1. That the school shall abide by the provision of DSER, 1973 and Rules framed thereunder as well as instructions issued by the Dte. of Education from time to time.

2. That the school shall admit students without any discrimination of caste and creed and as per the norms of the Deptt.

3. That the school should always appoint full time qualified and eligible staff as per the norms of the Deptt.

4. The school shall dispense with the services of unqualified and over-aged staff, if any, immediately.

5. That the school shall strictly abide by the provision of Section-10(1) of DSER, 1973.

6. That the service contract between the Management and the employees be revised as per DSER, 1973 and shall be executed immediately. The copies of the appointment letter is to be issued to the staff and also provided for verification.

7. The Managing Committee shall regulate the functioning of the school strictly in accordance with the provisions of DSER, 1973.

16. That the staff has been paid all the arrears and are being paid salary as per Vth Pay Commission recommendations. To be given to E.O. of the Zone for verification.
17. Medical facilities/leave, LTC, bonus, teaching allowances, medical allowance, PF etc. be paid since recognition of the school.
18. Provident Fund register, cash book is to be maintained and completed and shown to E.O. of the Zone for verification from time to time.
19. That the Management of the school shall create a reserve fund to the tune of 3 months salary of the staff or one rupees plus 80 rupees per student, whichever is less in joint account in the name of Deputy Director of Education South and the Manager of the School in a Nationalised Bank.


